**ACTIVE** MEMBERSHIPS SHALL CONSIST ONLY OF THOSE PERSONS WHO ARE ACTIVELY ENGAGED AS APPOINTIVE HEADS OF CERTIFIED LAW ENFORCEMENT AGENCIES WHICH OPERATE IN THE COMMONWEALTH OF VIRGINIA AS WELL AS EXECUTIVE AND/OR ADMINISTRATIVE OFFICERS WITH RESPONSIBILITY OF AT LEAST BUREAU OR DIVISION COMMANDERS OR SIMILAR STATUS AS DESIGNATED BY THE HEADS OF SUCH AGENCIES..

**ASSOCIATE** MEMBERSHIPS SHALL INCLUDE THOSE PERSONS INVOLVED IN LAW ENFORCEMENT OR LAW ENFORCEMENT RELATED OCCUPATIONS, OR INDIVIDUALS SINCERELY INTERESTED IN THE ADVANCEMENT OF THE LAW ENFORCEMENT PROFESSION, BUT NOT ELIGIBLE FOR ACTIVE MEMBERSHIP AS PROVIDED IN ARTICLE 1, SECTION 2. ASSOCIATE MEMBERS SHALL BE PERMITTED TO ATTEND THE MIDYEAR AND ANNUAL MEETINGS, AND PARTICIPATE IN DISCUSSIONS, BUT SHALL HAVE NO VOTE, SHALL NOT BE ELIGIBLE TO HOLD OFFICE IN THE ASSOCIATION, AND SHALL NOT BE COUNTED AT ANY TIME IN DETERMINING A QUORUM OR MAJORITY FOR ANY PURPOSE.

**SENIOR** MEMBERSHIPS SHALL CONSIST OF THOSE PERSONS WHO ARE PRIOR MEMBERS OF THE VACP, UPON RETIREMENT FROM THE LAW ENFORCEMENT PROFESSION OR AFFILIATED COMPANIES WISH TO REMAIN ACTIVE IN THE ASSOCIATION. UPON REGULAR PAYMENTS OF DUES OF AN AMOUNT TO BE DETERMINED BY THE EXECUTIVE BOARD, SUCH MEMBERS SHALL BE ENTITLED TO ALL PRIVILEGES AND BENEFITS OF THE ASSOCIATION INCLUDING RETENTION ON THE ASSOCIATION MAILING LIST. THEY SHALL NOT BE ENTITLED TO VOTE, NOR HOLD ANY ACTIVE OFFICE AND SHALL NOT BE COUNTED AT ANY TIME IN DETERMINING A QUORUM OR MAJORITY FOR ANY PURPOSE.
